INFORMATION regarding privacy pursuant to Article 13 of the GDPR-EU Regulation n. 679/2016

Dear Sir / Madam, We wish to inform you, as Data Controllers, that the EU / 2016/679 General Data Protection Regulation (GDPR), immediately applicable also in Italy, awaiting the issuing of the Decree provided for by the Community Law n. 163/2017 provides for the protection of persons and other subjects regarding the processing of personal data. According to the law, this treatment will be based on principles of correctness, lawfulness and transparency and protection of your privacy and your rights.

According to the art. 13 of the G.D.P.R. , I provide you with the following information:

1. a) The personal details and contact details you provide will be used for the following purposes based on your consent and on the legitimate interest of the undersigned A.S.D / S.S.D.R:

Inclusion in the members' book and associated membership at the CSEN National Educational Sports Center through the peripheral committee to which we are affiliated and any other use related to the aforementioned membership and sports membership reports. The Data will be collected to communicate them to the Italian National Olympic Committee CONI for the purposes of managing the Register of Sports Clubs for the fulfillment of national obligations. b) Furthermore, upon specific consent, the data may be processed for communications of promotion and diffusion of the sport by the Italian National Olympic Committee.

2. The legal basis for this operation is:

Article 36 of the Civil Code; the tax legislation relating to non-commercial entities, in particular art. 148 of the T.U.I.R.; Article. 4 of the D.P.R. 633/72; Article. 90 of Law 289/2002 and the CONI and Federal regulations concerning membership and participation in activities organized by these bodies or with their participation.

3. The legitimate interests of the data controller pursued with this activity are a clear and correct application of the statutory provisions on the internal organization and the administration of the association, the possibility of using the tax benefits due to the association, the possibility of participating to the activities organized by the bodies mentioned in the previous point 1.

4. Data will be processed as follows: on manual cards, made also with the aid of electronic means, kept in closed places, whose key is held by the President and by the persons in charge of the administration, or in a computerized manner, on a PC placed at the headquarters of the Association which is adequately equipped against IT risks (firewall, antivirus, periodic data backup); authorized to access such data are the President and those in charge of the administration. According to the art. 4 n. 2 of the G.D.P.R., the processing of personal data may consist of the collection, registration, organization, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and distribution of data.

5. Personal data will be kept for as long as necessary for the correct keeping of the register of members and / or for proceeding with the formalities required for the CSEN National Educational Center, by the rules and regulations of the CONI and by the National Educational Sports Center to which we are affiliated. The check on the obsolescence of the data being processed with respect to the purposes for which they were collected and processed is carried out periodically.

6. The provision of data is mandatory for the achievement of the purposes of the Association / Company Statute and is therefore indispensable for accepting your application for membership and / or for registering with the subjects indicated in the previous point; any refusal to supply them will make it impossible to accept your application for registration and / or membership, as it is not possible to establish the aforementioned membership and / or membership relationship at the National Educational Sports Center and registration with the Registry CONI

7. The personal data may be communicated to the National Educational Sports Center to which we are affiliated, also through its peripheral bodies; all data will not be disclosed to other parties, nor will they be circulated.

8. The treatment will not concern personal data that fall within the category of "sensitive" data, that is to say "the personal data that can reveal the racial and ethnic origin, the religious, philosophical or other beliefs, the political opinions, the membership in parties, trade unions, associations or organizations of a religious, philosophical, political or trade union nature, as well as personal data that can reveal the state of health and sexual life ". Health data, in particular the certificate of good health, if required and required for insurance and legal purposes, are kept by the President.

9. The data controller is ASD Aicowed with headquarters in Cernusco Sul Naviglio, Strada Padana Superiore, 77, 20063-Milano (Italy).

11. At any time you may exercise your rights to know the data concerning you, to know how they were acquired, to check whether they are accurate, complete, up-to-date and well-kept, to receive data in a structured, commonly used format, readable by an automatic device, to revoke any consent given in relation to the processing of your data at any time and to object in whole or in part to their use as sanctioned by articles From 15 to 20 of G.D.P.R.. These rights may be exercised through a specific request to be sent by registered mail to the addresses indicated in point 9 - or PEC - to the Data Controller.

12. You have the right to withdraw your consent at any time without affecting the lawfulness of the processing based on the consent given before the revocation. This right can be exercised by sending the revocation of consent to the email address indicated in the previous point 9 or 10.

13. You have the right to complain to the Guarantor for the protection of personal data to the different supervisory authority that should be established by the Decree provided for by Community Law n. 163/2017.

14. There is no automated decision-making process, nor any profiling activity pursuant to art. 22, paragraphs 1 and 4 of the G.D.P.R.
